PAYMENT TERMS:

If you do not have an established credit account with Amethyst Hill Nursery, please send payment for the entire purchase price, including shipping charges, prior to the shipment of your order. If you have an established credit account with Amethyst Hill Nursery, buyer promises to pay Amethyst Hill Nursery in U.S. funds the amount shown as due on the invoice within 30 days of shipping. After 30 days, all discounts are lost. Overdue accounts are subject to a service charge at a rate of 2% per month on the balance and if not so paid at any time, all principal and interest, at the option of Amethyst Hill Nursery, to become immediately due and collectible.

Notwithstanding the foregoing Amethyst Hill Nursery makes no warranty for loss of plants shipped bare root. On all common carrier shipments, customers must check the condition and count of the nursery stock at the time of delivery. No claim for shortages, damaged stock or errors in filling an order will be honored unless it is made in writing on the Bill of Lading upon receipt of the shipment. Failure to make a claim on the bill of lading shall constitute a waiver of your right to a refund. Where shipments are not by semi-truck, Amethyst Hill Nursery will carefully pack all stock and make reasonable efforts to secure prompt careful handling by the transportation company. However, our responsibility ceases upon delivery of stock in good condition to the transportation company. If shortages, damaged goods, or errors in an order occur, customer should immediately file a claim with the transportation company (air freight, UPS, etc.). GENERAL CONDITIONS:
